#### President's Report

2022 was 150 years since the official naming of the tin town of Stanthorpe and the Amiens History Association combined, on two occasions, with other community organisations to celebrate this milestone. Our first Tin Day was held in May in conjunction with the Stanthorpe Little Theatre's production of a play re-enacting those early days. Despite horrendous weather, there was a good turnout of visitors and so we decided to team up with the Heritage Railway group to revisit the event in August. A particular thank you to Colleen for representing AHA on the S150 committee. We again held our annual fundraising dinner, this year with a German theme and silent auction at the Stanthorpe RSL Club. One of our greatest areas of growth in 2022 was in the number of tour groups who visited our centre and the purchases of souvenirs and books as well as donations, often association with these tours. Winter and spring, in particular, was a very lucrative period with visits, morning teas, lunches and dinners by several large groups. In total \$13 595 was raised through tours, sales and donations in 2022. Thank you to all who have helped with these tours, especially Denise, who has been the main liaison for group bookings.

Recently, we have changed our opening time from Sunday to Saturday and while this trial is still in its infancy, I think it is proving successful. I would like to thank each and every volunteer who gives generously of their time, skills and resources to act as tour guides, ambassadors, cleaners, gardeners, plumbers, carpenters, painters, plasterers, shop assistants, grant and letter writers, technicians, financiers, and so much more. I urge everyone to take this opportunity to acknowledge each other's contributions, big or small, practical or administrative. It is not always smooth sailing — working with people never is — but in my two years in this chair, I have never once doubted the good intentions of every single person who is involved with AHA and the ALC.

As one looks around the grounds of the Amiens Legacy Centre today, the site has taken on a look of settled permanency. The gardens are coming into maturity, the poppy field is a wonderfully eye-catching attraction in Spring and the buildings are beginning to come together around the village green to form a neat site that tells a broad but cohesive story. While the Pikedale Soldier Settlement, the branch line and the Amiens village remain the central focus of the organisation, expansion into other aspects of our history and culture are becoming more evident and are attracting interest from a wider cross-section of the community. The indigenous garden and information board, the tin area with information and regular panning demonstrations as well as the popular revenue stream of tin souvenirs and jewellery have expanded AHA's scope and are excellent additions to the Amiens legacy. This is set to continue into the coming year with the launch of an exhibit dedicated to Pastoralists with a model of the Pikedale Homestead as the centrepiece as well as plans afoot for an environmental project in the Memorial grounds. Other exhibits concerning the Branch Line and Western Front, Soldier Settlers and Amiens Village, will all soon take on renewed vigour as we expand into the Resource Centre, now complete. An office and shop will also, hopefully, follow. Thank you to all who have come together to bring the creation of the ARC to fruition and good luck to all who will continue with the fit-out of the interior. I think this is a very exciting chapter for the association.
